1. The employees will take their seniority in the new seniority unit to which they are transferred as per extant instructions applicable to mutual transfer i.e. they will retain their own seniority or take the seniority of other in new seniority unit whichever is lower.
2. They will retain their lien in their parent division till such time they are permanently absorbed in the new seniority unit.
3. They shall not seek retransfer to their parent division at a later date.
4. As the transfer is ordered at their own request they are not entitled to any transfer benefits.
5. There are no DAR/SPE/Vig Cases pending against them on the date of relief.
6. The employees should hand over railway property/materials entrusted to them by their supervisory officials before affecting transfer order. Supervisory officials concerned must ensure this before relieving them.
7. They should vacate the Railway Quarters, if any, under their occupation, the leave record along with SR & LPC duly completed in all the respect of Sri.G.Suryanarayana Tech Gr.I(SM)/NED of NED Division may be sent directly to DRM (P)/BZA.
8. The instructions contained in Railway Board's letter No.E(NG)-2001/TR/16 dated 21.10.2001 (RBE 229/2001) may be strictly followed while relieving Sri.G.Suryanarayana Tech Gr. I(SM)/NED of NED Division with instructions to report DRM(P)BZA of South Central Railway.
